RESOLUTION NO. 78-52

AMENDING RESOLUTION NO. 76-105
(ESTABLISHING CENTRAL AVENUE
UNDERGROUND UTILITY DISTRICT)

WHEREAS, the Humboldt County Department of Public Works has recommended to the Board of Supervisors that Resolution No. 76-105 be amended to set forth new dates for the property owners to start receiving service through underground utility facilities and for removal of poles by the public utilities involved;

NOW, THEREFORE, BE IT RESOLVED that the second resolved clause on page 2 of Resolution No. 76-105 be and hereby is amended to read as follows:

"BE IT FURTHER RESOLVED by the Board of Supervisors that the affected property owners residing along that portion of Central Avenue from 250 feet south of the south right of way line of School Road to 25 feet north of the north right of way line of Railroad Avenue shall be ready to receive service by March 1, 1979, and shall be fully converted over by May 1, 1979. Furthermore, all utility poles and related overhead utility facilities shall be removed from the right of way of Central Avenue by June 1, 1979."

BE IT FURTHER RESOLVED that the County Clerk is hereby instructed to notify all affected utilities and all persons owning real property within the Central Avenue Underground Utility District of the adoption of this resolution within ten (10) days after the date of such adoption. Such County Clerk shall further notify said property owners of the necessity that, if they or any person occupying such property desire to continue to receive electric, communication, or other similar or associated service, they or such occupant shall, by the date fixed in this resolution, provide

all necessary facility changes on their premises so as to receive such services from the lines of the supplying utility or utilities at a new location, subject to applicable rules, regulations, and tariffs of the respective utility or utilities on file with the Public Utilities Commission of the State of California.
