FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR VOTE BY MAIL OR PROVISIONAL BALLOT NOT TO COUNT.

The signature on your vote by mail or provisional envelope does not match the signature in your voter record.

The Humboldt County Office of Elections received your vote by mail or provisional envelope, but your signature does not match the signature in your voter record. By law, a voter's signature must be verified before the ballot may be counted. Your signature may have changed over time.

In order to ensure that your vote by mail or provisional ballot will be counted, your statement must be received by the Humboldt County Office of Elections no later than 5 pm two days prior to **certification** of the **Statewide Special Election**.

Fill out and sign the Signature Verification Statement. It can be returned to the Office of Elections in any of the following ways:

Mail your signed completed statement in the enclosed envelope. The Signature Verification Statement must be received at our office before 5:00 pm two days prior to the election certification.

Submit your completed form by email or fax. The Signature Verification Statement must be received at our office before 5:00 pm two days prior to the election certification.

Bring this completed Signature Verification letter to our office. This must be received at our office before 5:00 pm two days prior to the election certification.

Deliver your signed statement on Election Day to any Vote Center in Humboldt County before the close of polls (8:00 pm) on Election Day, June 2, 2026.

Please note that the signature provided on the completed Statement may be added to your registration record for signature comparison purposes in future elections.

SIGNATURE VERIFICATION STATEMENT

I, _____ (Voter Name), am a registered voter of Humboldt County, State of California. I declare under penalty of perjury that I requested and returned a vote by mail or provisional ballot. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the vote by mail or provisional envelope. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years. I understand that my failure to sign this statement means that my vote by mail or provisional ballot will be invalidated.
