Tier Definitions**

Community Risk	Individual Risk	Adjusted Case Rate	Positivity Rate
Widespread Tier 1	Widespread outbreak that is growing with many undetected cases. Take strong measures to limit all contact.	More than 7 daily new cases (per 100k)	More than 8% positive tests
Substantial Tier 2	Many cases with conditions for community spread, with many undetected cases likely. Limit everyday activities to increase safety.	4 - 7 daily new cases (per 100k)	5 - 8% positive tests
Moderate Tier 3	Moderate number of cases with majority of cases from a known source. Increase efforts to limit personal exposure.	1 - 3.9 daily new cases (per 100k)	2 - 4.9% positive tests
Minimal Tier 4	Cases are somewhat sporadic, and contact tracing can be used to control the virus. Take everyday enhanced precautions.	Less than 1 daily new cases (per 100k)	Less than 2% positive tests

*Data used by the state to determine tier assignment. Local and state numbers rarely align because local data is updated daily, whereas the state's data is calculated over a seven-day period with a seven-day lag and is updated each Tuesday.

**The state's "Blueprint for a Safer Economy" includes a Health Equity Metric, which requires having similar positivity rates across a county to demonstrate that no community is disproportionately impacted by COVID-19. Meeting this metric is necessary before movement into a less restrictive tier, and in some instances may allow earlier movement. Read more about the [Health Equity Metric](#).

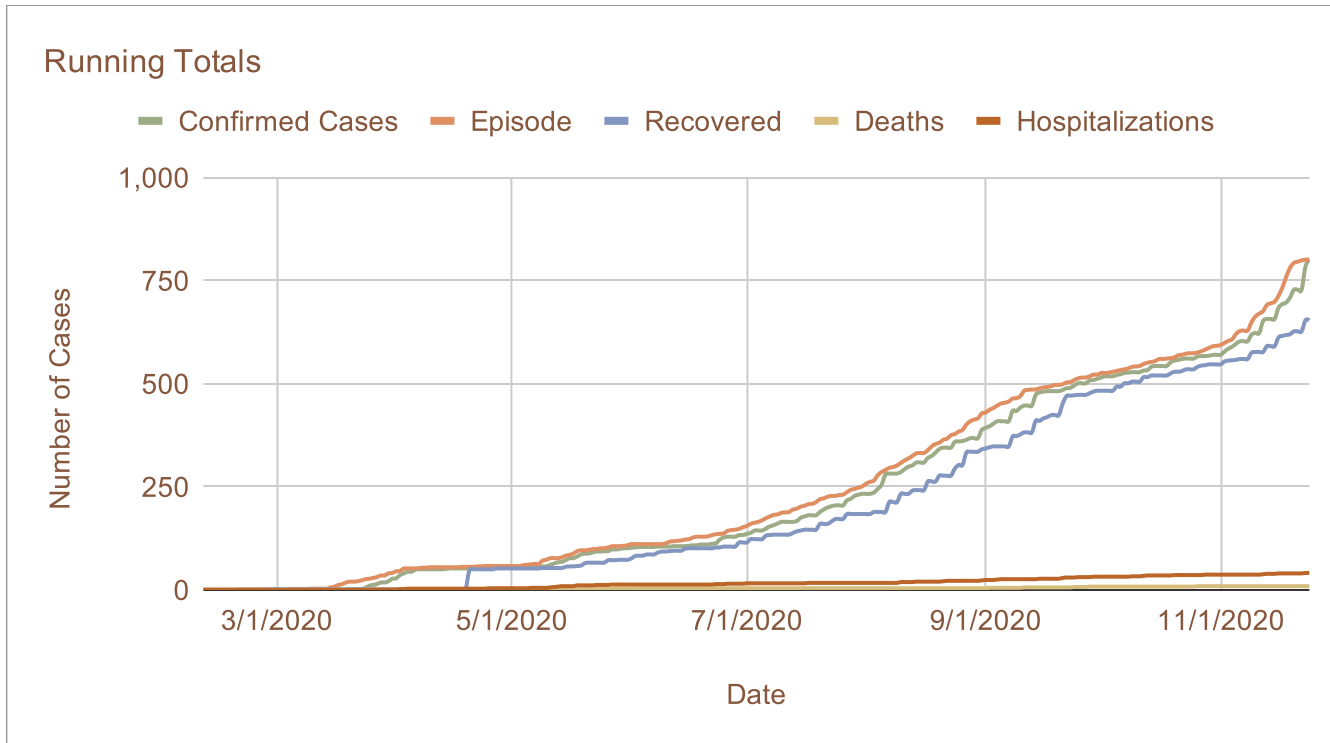

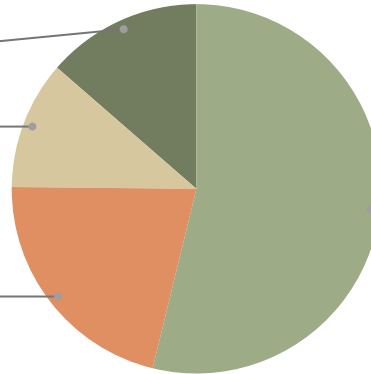

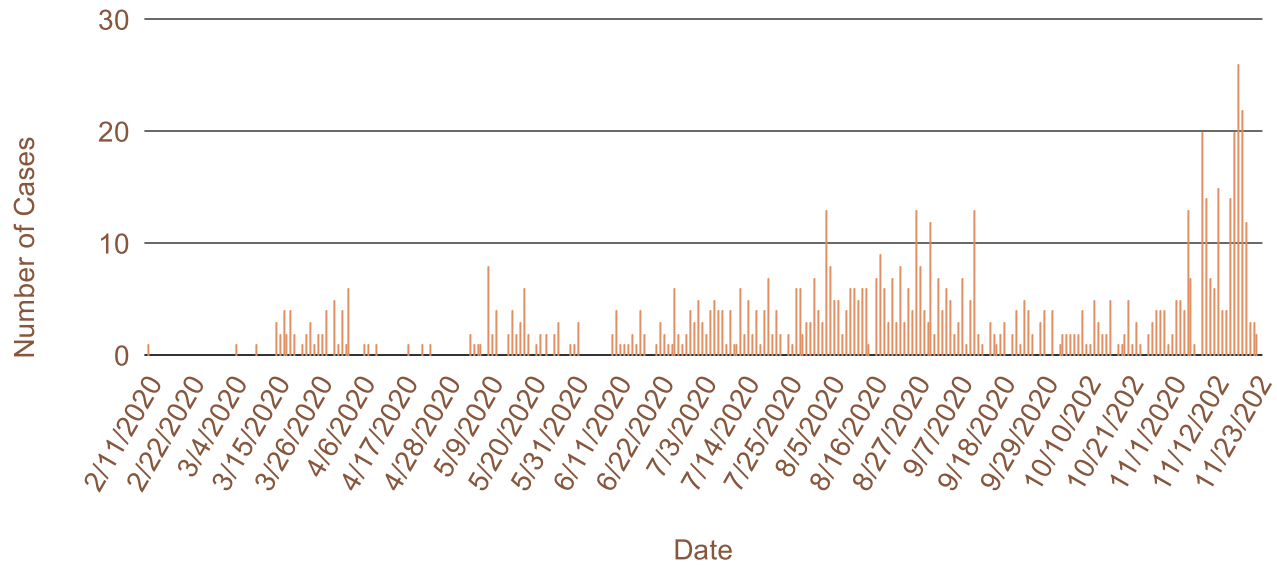

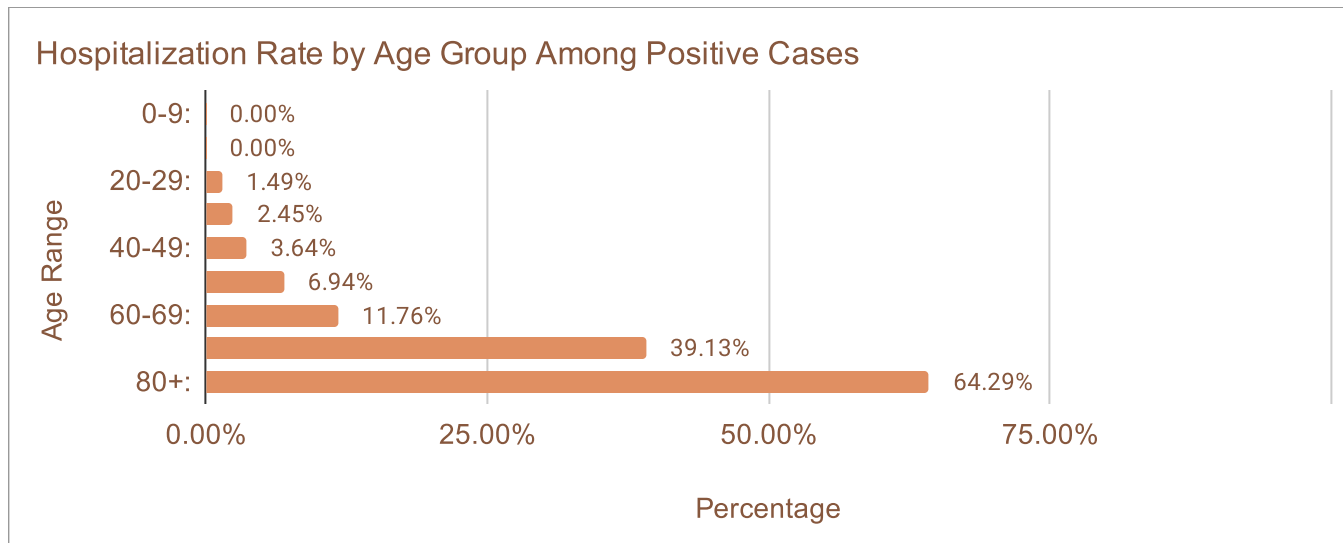

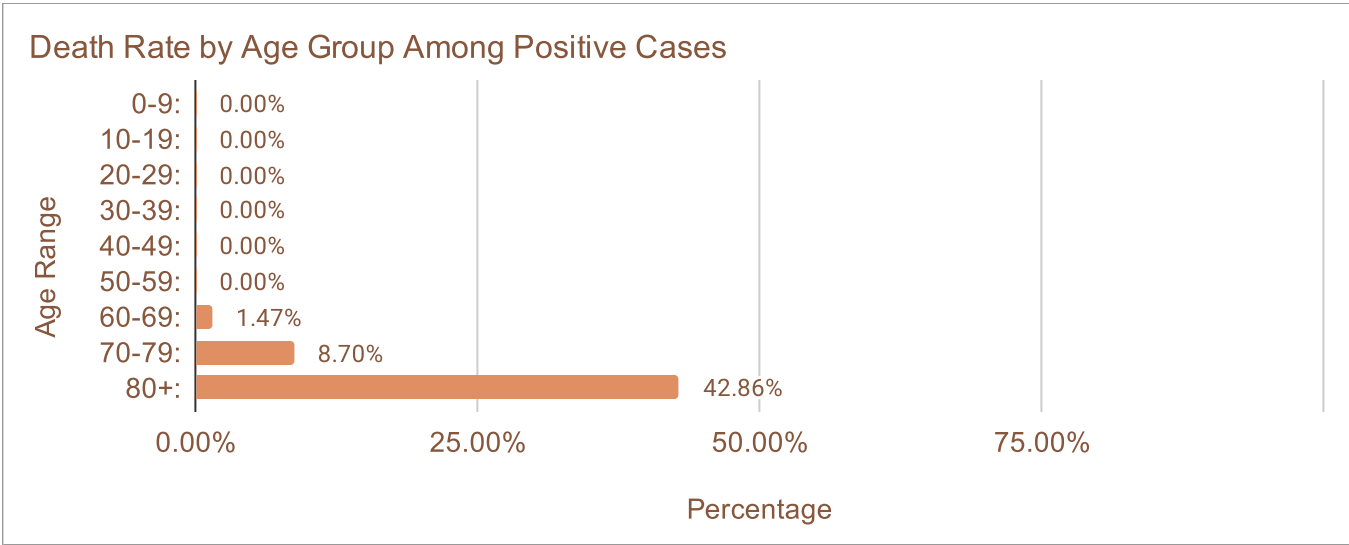

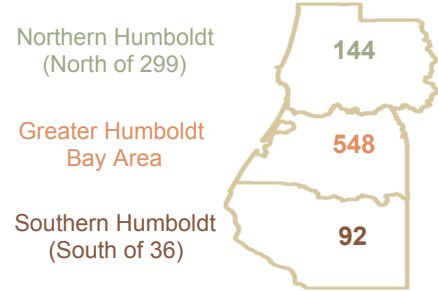




Cumulative Positive Test Rate since 2/11/2020

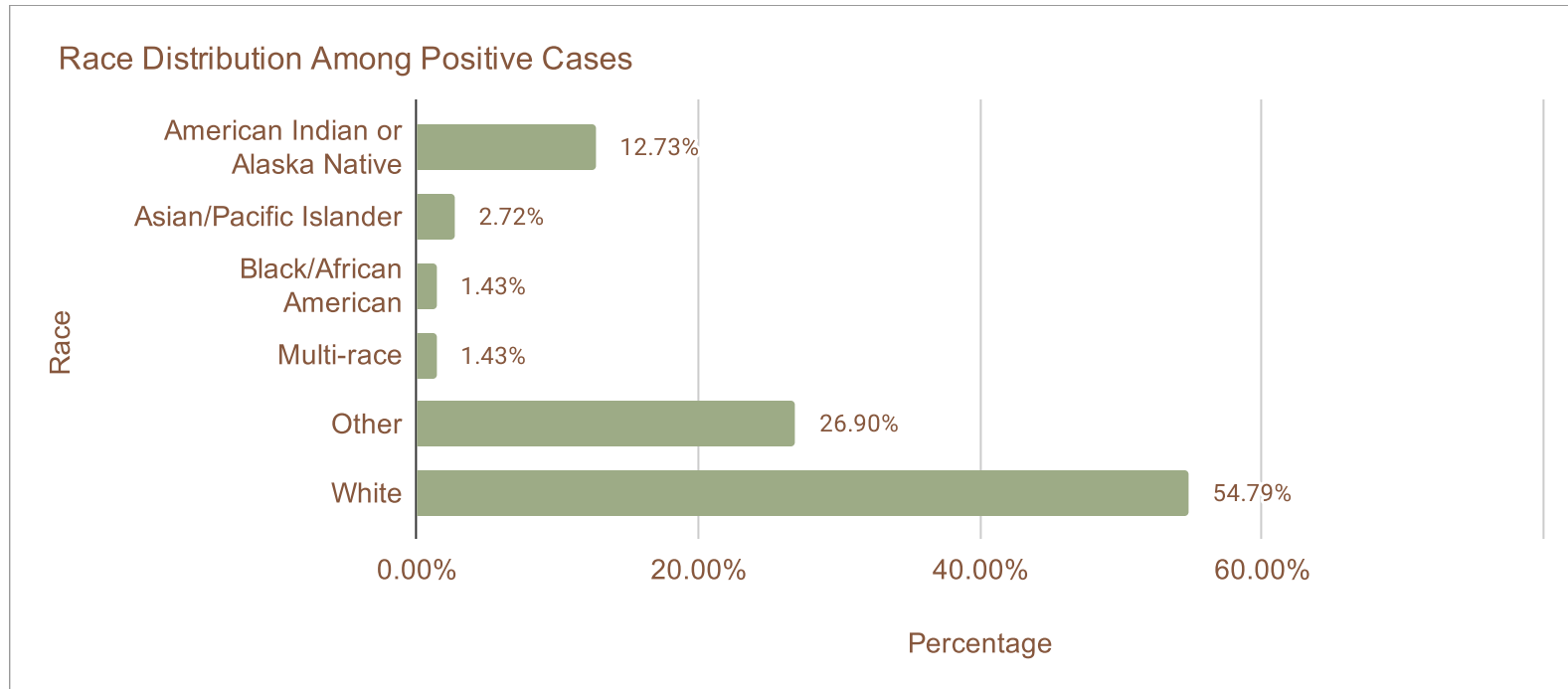

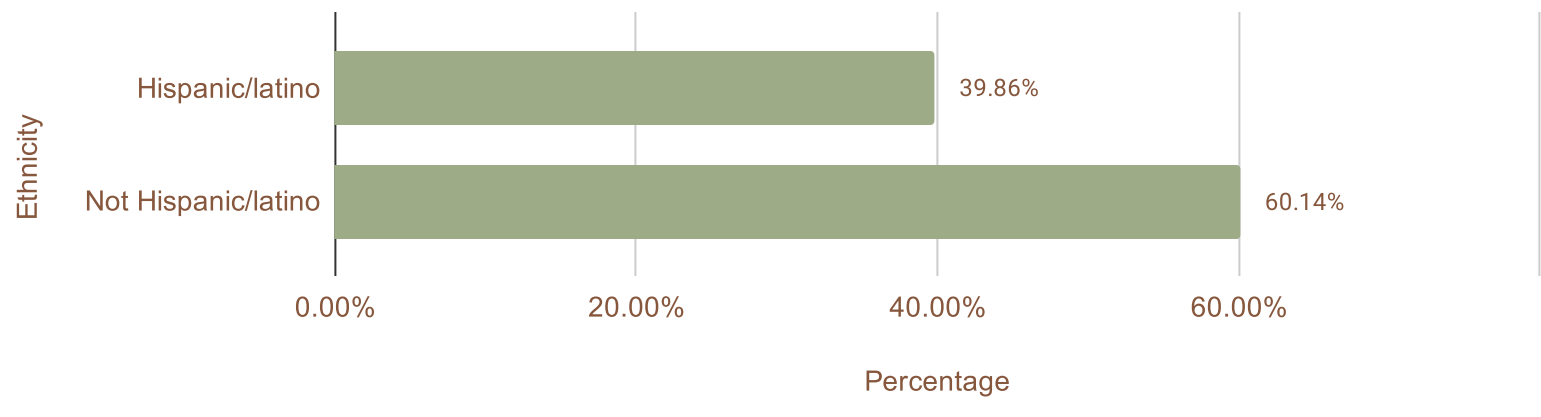

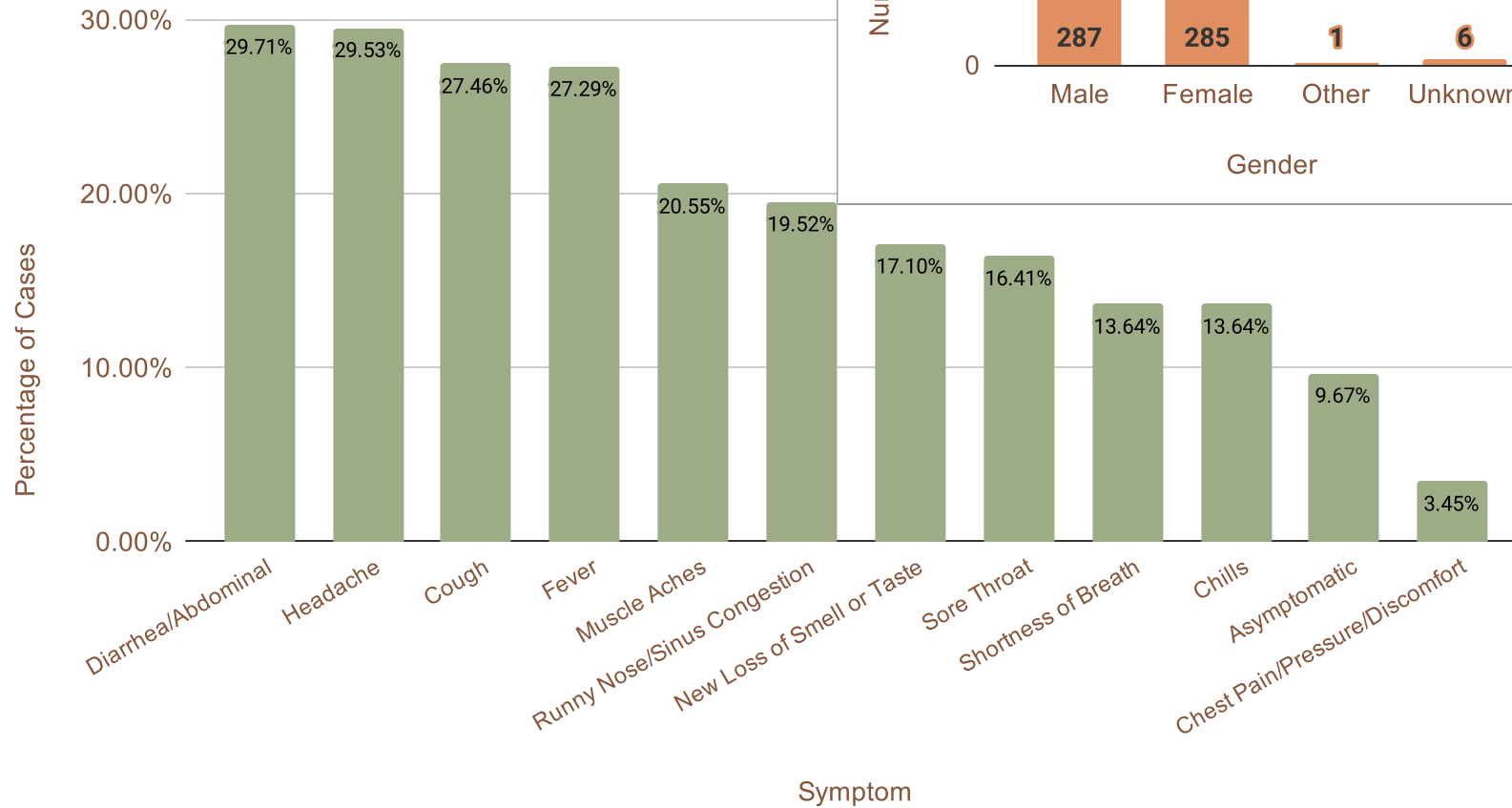
